I trust well. I have been getting a lot of people asking me to do a follow up on the WMA since Operation Talla Indictment and recently more so in the past six weeks. I Am sending the attachment to yourself trusting you can pass it on to the relevant person who will be able to deal with this investigation.

Over time many matters have been raised by Martials that are concerning a lot of people. Some of the claims are that all legislation in UK is illegal, null and void, and that some Martials are making claims of authority, making indictments and claiming arrests are imminent.
