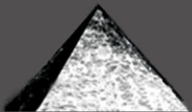

Strictly no third-party involvement with WMA.



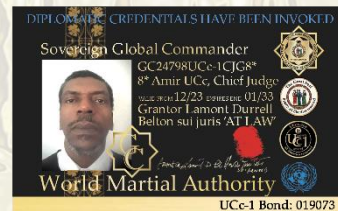
