**Aboriginal Titled Uniform Commercial code 1930 Geneva Convention
sanctioned, effective actively at force / enforced fully assured supreme land law
governing all secured commercial transactions, and all public debtor civil
financial transactions, both public and private. However, the Uniform Bonding
code is regulatory authority over all statutory civil, Federal, and State revenue**

officers behavior as civil officers, operating under Uniform Commercial code (UCC), Uniform Bonding Code (UBC). All Revenue/Civil officers are to be of good behavior, while acting as public security dealers, collecting revenue, via municipalities. Municipalities are defined via UBC as renegade governments, non-insured, assurance not, while acting as agents for the principal such as police, sheriff, judges, governors, presidents, et alii. This may include the private sectors all actors especially pretending at commerce including finance aka financials. Finance and financial words are sometimes used to deceive and manipulate! U.S. Civil banks and institutions finance, financial definitions are common law cheats, and is guilty of breaching Title 31 USC 5118 (d)(2)!

sec. 408) The compelled use of a social security number is a felony. The number is
only for social security insurance, not for obtaining services, permits or license,
this is illegal up to 5 years or more in Federal Prison! (42 USC sec 1983). Public
official or any party that compels usage of a social security number shall be liable,
and shall be at common law, generally understood to be the first arrest, first lien/
levy and is the only Remedy Jurisdiction!**

Uniform Commercial code 1-201 Jurisdiction General Definition

1-201 (2) Aggrieved Party means a party to pursue remedy

1-201 (32) "Remedy" means any remedial right to which an aggrieved party is entitled with or without resort to a tribunal. Sending notice via Service and Process to the registered agents directly from Aboriginal Consular Court Insular Tribunal, Sovereign Court of International Justice perfects remedy. The UCc provides that none of the corporate entities have any jurisdiction, no judging, and no injunction over the natural born.

Memorandum: 1998 ICC Rome Statute MANDATES that "Elements of a crime shall [be]...interpret[ed]" by the independent Judiciary of an International Court (Article 138).

Common law is international law. All Local statutes/laws are stayed domestically via UCc obligor code of Virginia 1-500 Great Seal Perseverando, and at UCc obligor debtor code of Virginia 1-200 ,common law, land law, supreme law, 1st lien levy and arrests / ARREST generally understood, is at common law, that is active effective legally binding on all legal fictions, example such as Colonial U.S. Congress Federal and State or Statutory Corporations, all bound under common law UCc bankruptcy as colonial color of law, color of authority, color of office obligor, same for UCc debtor Parliament as domestic code reads!

See example, obligor code of Virginia 1-201 Parliament, benefit of all writs remedial and judicial, THE ONLY REMEDY JURISDICTION ARE WRITS, domestically and customary internationally, binding on all continents, countries, courts, governments. Private and Public Officials, employer, employees, principles and agents' signatories and non-signatories via governments obligations to govern with "gentleness and wisdom" by "virtue and "virtuous friendship"

see Critias Manuscript (ca. 400 BC) documented that the ancient Royal Alliance of Independent States (RAIS) was formed by a 16,000-year existing active effective Treaty of "special laws which the several kings had inscribed about the temples,

requiring, to date, for all governments and actors to govern at good behavior non injurious!

Governments are to uphold the rule of law, their own national sovereignty, and the human rights of their people, as required by the modern framework of conventional international law! this is why the UBc and UCc exist today as a form of guarantee / guarantor for this treaty spirit!

UCc Great Seal Perseverando code of virginia, Title 8.1A-305 Remedies to be liberally administered

(a) the remedies provided by the Uniform Commercial code shall be liberally administered to the end that the aggrieved party may be put in as good position as if the other party had performed but neither consequential or special damages nor penal damages may be had except as specifically provided in the Uniform Commercial code or by other rule of law.

(b) Any right or obligations declared by the Uniform Commercial code is enforceable by action unless the provision declaring it specifies a different and limited effect.
