**the Great Seal Perseverando the reverse side,**

(as shown above) pictures the blessings of freedom and peace, as represented by three Roman goddesses. In the center is the matron, **Libertas**, the goddess of individual liberties. In her hand she holds a wand showing her magical gifts, at the top of the wand hangs a Phrygian Cap, also called a Liberty Cap – later made popular by French revolutionaries.

To the left of Libertas stands **Ceres**, the Roman goddess of **agriculture**. In her left hand is a horn of plenty overflowing with abundance of the Great Seal “Perseverando” harvests, while in her right hand is an enormous stalk of wheat, representing one of the Great Seal “Perseverando” leading crops. **Aeternitas**, representing the Great Seal “Perseverando” eternity, stands at the right of **Libertas**. In her right hand is a golden ball, an emblem of authority, and atop the ball is a **Phoenix**, symbolizing immortality. On the Great Seal “Perseverando”, the phoenix represents effective government, (the ‘American Republic’). See ancient Mu’ur lands T Amerikhan T-amaru Timucuan, same ancient lands before colonial trespass against T-Amerikhan is America, pre Columbian pre London Company Elizabethan Virginia adventures foreign explorer colonist-trespasser, now Debtor under UCc bankruptcy!

The **motto** gracing the reverse with its trio of Libertas, Ceres and Aeternitas is the Great Seal “Perseverando” or in English “Persevering”, a **reminder to future generations of the need to persist in maintaining the blessings of liberty “Promulgated and de creed” secured via GLDB LRI 019073.. American Republic, and UCc 08-10-08-7015-1.** The ornamental border on both sides of the seal consists of springs of Parthenocissus quinquefolia or commonly “the Great Seal ‘Perseverando’ “creeper”.

In 1930 another committee was charged with standardizing the seal’s design because of all the variations that came into use over the years.

The two seals that now adorn the doors of the Southern Portico of the Capitol in Richmond were designed by Charles Keck. **What the committee approved was basically adopting the 1776 Great Seal “Perseverando” as the standard.** In 1949, another standard was implemented, via the TRESPASSERS, Elizabethan ADVENTURERS, THE EXPLORERS, LONDON ADVENTURERS **committee**, these Trespasser Adventures Colonizer are the same foreign person called **VIRGINIA’s Art Commission**, defined the official color scheme for the seals. lesser seal have different meanings. The lesser seal, VIRGINIA, the **dissolved fiction**, is used on commissions of commonwealth officials and notaries, and on other papers which **remain only within the boundaries of/or relate only to, VIRGINIA LONDON COMPANY** ('STATE OF'. Dissolved fiction).

**The Great Seal "Perseverando"** (American republic), shall consist of two metallic discs, two and one-fourth inches in diameter, with an ornamental border one fourth of an inch wide, with such words and figures engraved thereon as will, when used, produce impressions to be described as follows: On the **obverse side of the VIRGINIA dissolved**, Virtus, the genius of a Republic same as (Commonwealth), dressed as an Amazon, resting on a spear in her rights hand, point downward, touching the earth; and holding in her left hand, a sheathed sword, or parazonium, pointing upward; her head erect and face upturned; her left foot on the thorn of Tyranny represented by the prostrate body of a man, with his head to her left, his fallen crown nearby, a broken chain in his left hand, a scourge in his right. Above the group and within the border conforming therewith, shall be the word "**VIRGINIA**" (**LLC DISSOLVED**) and, in the space below, on a curved line, shall be the motto, "Sic Semper Tyrannis".

VIRGINIA, the dissolved fiction, color of law/'crimen falsi' secretary of the commonwealth (another legal fiction) was the keeper of both seals, however, at trust to fully disclose her TRESPASS status and her allegiance ONLY to VIRGINIA governor's cabinet. The Great Seal Perseverando 1776 On the **reverse side, the Great Seal "Perseverando"**, shall be placed a group consisting of Libertas, holding a wand and Phrygian cap in her right hand; on her right, Aeternitas with a globe and phoenix in her right hand; on the left of Libertas, Ceres, with a cornucopia in her left

hand and an ear of wheat in her right; over this device, in a curved line, the word the Great Seal “Perseverando”.

### The Great Seal “Perseverando” meaning

1. The central figure in the design is Libertas (lee’ ber tas). She is the Roman Goddess for freedom.  
Libertas’ cap is the cap for freewoman and the Pileus is the cap for those who were freed from slavery. The trespassers, Adventures’ colorable attestation is that during the Revolution, the pileus was worn on American to show support for U.S. patriots.
2. The figure at the right of Ceres (seer’ es), the Roman Goddess of agriculture. She holds a sheath of wheat in her right hand. She holds a cornucopia in her left hand. (cornucopia, noun), (kôrn(y)ə kôpēə) a symbol of plenty consisting of a goat’s horn overflowing with flowers, fruit, and corn.
3. The figure at the left is Aeternitas (I ter’ nee tas). Aeternitas means “eternity. Eternity (noun), infinite or unending time.
4. Aeternitas holds a phoenix. The phoenix (noun) represents (in classical mythology) a unique bird that lived for five or six centuries in the Arabian desert, after this time burning itself on a funeral pyre and rising from the ashes with renewed youth to live through another cycle.
5. Aeternitas also holds a globe representing the world (symbolizing all the lands within the boundary of earth). -Gandaberunda[Vishnu]/Khatti seal-
6. The motto, says or reads the Great Seal “Perseverando” (pear se ver an’ do). This is Latin for “by enduring”. Symbolizing that “at Honor we sustained the blessing of Liberties”.

The Great Seal “Perseverando” is the only Sovereign Seal on the aboriginal Lands. VIRGINIA IS DISSOLVED!! The UCc1 jurisdiction is the only jurisdiction that is active in sustaining the blessing of Liberties. **the Lesser Seal Virginia, obverse side,** From CORPORATE WIKIPEDIA, the free encyclopedia, duties of the SECRETARY OF THE COMMONWEALTH 2005 Janet Kelly, are:

Serving as the keeper of the Seal of the Commonwealth; Assisting the GOVERNOR in the appointment of thousands of individuals to serve on state boards and commissions; Issuing the Commissions of Notary Public; Authenticating documents; Registering lobbyists; Issuing the “Bluebook”, officially “The Report of the Secretary of the Commonwealth”, “an annual publication that identifies, (a) the boards of visitors of all public institutions, and other boards appointed by the Governor; (b) all commissions issued under

appointments made by the Governor, except commissions to notary publics; (c) all departments, boards, councils, commissions, and other collegial bodies created in the executive branch of state government, and (d) such other matters as the Governor requires.”; Issuing a State Government Organization Chart; Handling pardons and clemencies, restoration of civil rights of former felons, extraditions, and service of process. Although the Secretary is involved, the Governor is responsible for granting pardons, clemency and restorations of rights, as well as authorizing extradition, the Secretary of the Commonwealth’s Office handles the paperwork on behalf of the Governor.

In a unique twist of VIRGINIA’s “color of law”, unlike other members of the Governor’s Cabinet, the Secretary of the Commonwealth does not resign immediately upon the inauguration of a new Governor, but remains in office for an additional week, serving a fixed term of four years in order to ensure a smooth transition and ensure continuity in government.

Although the office has evolved over the years, the job has always involved the safekeeping of the Great Seal of the Commonwealth of VIRGINIA. Under the VIRGINIA Constitution of 1901, the Secretary of the Commonwealth has been an appointed member of the Governor’s Cabinet.

In May 1776, the VIRGINIA colony declared its independence from Great Britain. On July 1, 1776, a committee of four was appointed to make a proper seal for the Commonwealth of VIRGINIA. The four men were Richard Henry Lee, George Mason, George Wythe, and Robert Carter Nicholas. Four days later the committee’s report for a design of the seal was read and George Mason presented it to the VIRGINIA de facto (government). It was voted on and approved that same day. It is not known for certain which members of the committee were chiefly responsible for the design of the seal, but it is generally believed to be principally the work of George Wythe.

The seal makers did not want a design which in any way resembled the style of coats-of-arms used in Britain because of the strong admiration for the Roman Republic felt by the VIRGINIA leaders, the design of the new seal was taken from the mythology of Ancient Rome. They also chose a two-sided design.

Bronze medals struck at behest of VIRGINIA governor, Thomas Jefferson and carried by Joseph Martin to give to Cherokee allies of colonial forces. Early variant of the official state seal with partially disrobed Virtus. 1780

**The obverse seal**, also known as the lesser seal (as shown above) is the official seal of VIRGINIA and is used on all the official papers and documents of the Commonwealth’s government, as well as on its flag. On this side, a female figure personifying the Roman virtue of Virtus was selected to represent the genius of the new Commonwealth. VIRGINIA’s Virtus is a figure of peace, standing in a pose which indicates a battle already won. She rests on her long spear, its point turned downward to the ground. Her other weapon, a parazonium, is sheathed; it is the sword of authority rather than that of combat. Virtus is typically shown with bare left breast; this is commonly recognized as the only use of nudity among the seals of the U.S. STATES.

Monarchical control of Great Britain; VIRGINIA and NEW YORK are only U.S. STATES with a flag or seal displaying a crown. The broken chain in Tyranny’s left hand represents VIRGINIA’s freedom from Britain’s restriction of colonial trade and westward expansion. The useless whip in his right hand

signifies VIRGINIA's relief from the torturing whip of acts of punishment, such as the intolerable Acts. His robe is purple, a reference to Julius Caesar and the Etruscan King of Rome, Tarquinius Priscus.

The motto selected for the obverse of the VIRGINIA's seal is **Sic semper tyrannis**, or in English, "thus always to tyrants". This is a derived quote from the famous events in Roman history, attributed to Brutus upon his participation in the slaying of Julius Caesar. (Caesar has been named perpetual dictator of Rome in the same years and some Senators believed had ambitions to abolish the Roman Republic and establish himself as a monarch). Civil War definition for Sic Semper tyrannis means get your foot off my neck!
