This is completely apart from any existing Corporate Social Care Sector globally which is NON-BONDED and NON-ASSURED, WITHOUT-STANDING i.e. No lawful Standing and has NO AUTHORITY TO OPERATE with ZERO JURISDICTION over Natural Law, living men and women. We are assuring that peoples values, wishes, and rights are protected and respected and never violated by any corrupted third parties.

Unfortunately, the number of requests for assistance that we are now processing through this route is shocking.

We have irrefutable evidence citing crimes against humanity with violations being committed by persons from all levels and departments across multiple Counties and Countries who work with or are affiliated to the Care Sector.

This is not something that should be happening as the Care Sector is in place to protect all people and communities, not to violate human rights.

Due to the severity and repeated occurrences of these violations in the many reports that have been shared with us, the only conclusion possible is that the care systems globally have failed the people they are supposed to be protecting. It has become a fraudulent misrepresentation and is committing acts of trafficking with a one-sided due process system and ACTING as Revenue Officers under an incorporated Bar Association that was cast out of Commerce in 1776 and under Corpus Juris 1789 volume 20.

All reports we receive will be investigated thoroughly and any persons cited on these reports, interviewed.

Due to the seriousness of this situation, and the high volume of requests for assistance, we will in some instances being issue an Interim Order/Cease and Desist Order for the protection of those aggrieved until our investigations conclude.

We have people proficient in all aspects relating to the care and assistance needs of any individual. We have our own Courts with International Jurisdiction with full Authority and power to arrest any person who irrefutably violates another.

For acts so notorious no due process is necessary.

People can now be confident that there is a lawful alternative to counter corruption, which is impartial, independent and operates with integrity, guaranteeing to support victims and has the Authority to bring about justice at all levels.

ON ISSUANCE OF INTERIM ORDER/CEASE AND DESIST ORDER IT IS IMPERITIVE THAT CONTACT BE MADE WITH WORLD MARTIAL AUTHORITY ALTERNATIONS AND ABORIGINAL CONSULAR COURT FOR DEFINITIVE REMEDY AND CONCLUSIONS.
