## **OPERATION TALLA Update and Clarification**

We have received a few requests for updates on progress and clarification as to the eligibility for any payment that the WMA credits in advance of any amount being recovered from those entities named in the OP TALLA Judgement.

Due to recent Defamations a new video will be released soon to update the public

### **PLEASE NOTE**

- Payment due is owed by the entities listed who have had Judgement made against them by the Aboriginal Consular Court Insular Tribunal.
- This amount has been spilt into £8,333/month for anyone affected.
- Any payment that the World Martial Authority WMA arranges in regard to the above amount is **a credit** and comes from World Martial Authority WMA funds, through Liberties Reserves.
- It is a payment made by World Martial Authority WMA to save people having to wait for the entities involved to pay out as per the judgement.
- Please comprehend, that although this payment is due as per the Final Judgement, **this amount is owed by the entities the judgement is against, & not the World Martial Authority WMA.**
- **WMA is not required or responsible for this payment and does not owe anything to anyone.**
- The World Martial Authority offered to credit the OP TALLA judgement **purely as a goodwill gesture** to assist people in being recompensed quickly, without having to wait for the perpetrators to pay out.

- Whether WMA credits this payment for individuals is completely at their discretion. There will be a series of questions on the account application form which will eliminate the applications from entities who are not eligible for any payment, due to their involvement at various levels in the crimes listed.
- **We will not fund any people who are attempting to harm us or others.**
- There will also be a minority of people who may be eligible under OP TALLA, but because of reasons unrelated to OP TALLA, the World Martial Authority **are not willing to provide them with the benefit of credit.**

***NOTE** in this instance, these people can still pursue the OP TALLA payment as per the judgement, directly from those entities that the judgement has been made against.*

*However, these people who have been refused credit from the World Martial Authority WMA will have to make their own claim for any payment they feel they are owed directly from the perpetrators.*

*They can use the OP TALLA judgement as reference and to support their claim.*

*Credit from the World Martial Authority WMA will cease immediately if anyone is found to have been causing harm to another by any means. In this instance, and for the continuity of their OP Talla Payments they will have to approach the perpetrators directly in the manner stated above and no further assistance from WMA will be given.*

### **Regarding Progress**

All funds necessary to cover the OP TALLA Judgement in full have been ready to deploy for several months. We are however working on an off ramp to allow us to interact with the CORPORATE banking sector in order for these funds to be distributed.

More details regarding the OP TALLA judgement will be made available as things progress. We hope you continue to appreciate that because of the nature of what we do we invariably encounter pushbacks which prevent us having a strict deadline.
